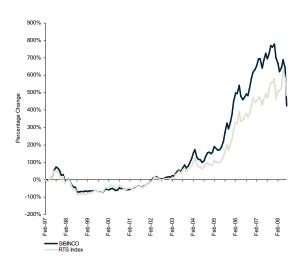

Investment Approach

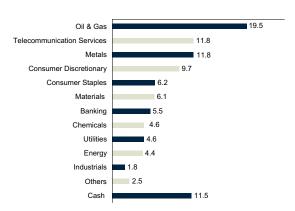

This may include value or cyclical companies that are restructuring to follow а sustainable growth path. Our intensive company research gives us the conviction of view to focus on the long term; to identify attractive investment opportunities independently of market indices and to invest across the market cap spectrum.

Fund Manager's Commentary

Fund Performance

In July, global equity markets witnessed a rotation out of commodity stocks into financials driven by a substantial correction in several commodities including oil, which declined from \$145.29/ bbl to \$124/bbl on concerns over its impact on inflation and global growth. Furthermore, the Russian market has declined substantially following Prime Minister Putin's criticism of Mechel's pricing policies that was perceived by investors as increased risk of government interference in the corporate sector.

In July, the Fund declined by 29.1% vs. a 14.6% decrease of the RTS. The main reason for such decline was the Board of Directors' decision to write off to nil the value of two legacy stocks whose trading is currently suspended due to the Russian Court injunction. This write off alone had a 12.71% negative impact on the Fund's performance in July.

Excluding the write off, the Fund's 3.60% outperformance vs. the RTS could be attributed primarily to its underweight in the energy sector vs. the Index that offset the negative impact of a broader commodity stocks correction. Energy stocks that represent 57.6% of the RTS were down 15.4% as investors re-assessed Russian political risk.

Key Changes to the Portfolio

Besides the Energy sector, the Fund benefited from its exposure to Industrials and Utilities sectors. Our new investment in GlobalTrans, Russia's largest private railway transportation company, positively impacted the Fund's performance.

In July, we added to our position in X5 Retail Group, a food retailer company and AFI Development, a commercial real estate developer, due to their attractive valuations. We also established new positions in Razguliay Group, Russia's largest agricultural company, in Novatek, an independent gas producer, and in GlobalTrans.

Current Market Outlook

Our positive outlook on Russia became challenged with Prime Minister Putin's aggressive criticism of Mechel's pricing policies in July and continuous lack of resolution in the conflict between BP and its Russian partners in the JV. We believe that these events have significantly increased Russia's country risk premium. More importantly, recent events clearly demonstrate that, regardless of Russia's continuous robust GDP growth, foreign investors have re-assessed the political interference and corporate governance risk in Russia, and are unlikely to treat the country as "safe haven" going forward.

The market could remain volatile in the next 6-months driven by increased political risk and exposure to commodities. Longer term, the fund will maintain its focus on achieving long-term capital appreciation through a selection of stocks with attractive valuations, sustainable earnings growth and cash flows and underleveraged balance sheets.
